### i. Surveillance & Enforcement

- Initiating the development of guidelines and procedures for compliance;
- Conducting inquiry on complaints with regard to any professional misconduct;
- Prepare procedure for compliance;
- Conducting compliance checks;
- Monitoring compliance with professional, quality assurance and other standards published by the Council for observance by the members of ICIFA.
